They can only be used in the approved vehicle as per our fit table provided on our website. Further, this warranty does not cover spark plugs damaged by abuse, accident, improper installation, application, or in another vehicle besides the original.

If your **PowerSTAR®** Performance Spark Plugs spark plugs prove to be defective during the two years or 20,000 miles after they were purchased, return them, along with your cash register receipt and the form below (properly completed), to:
